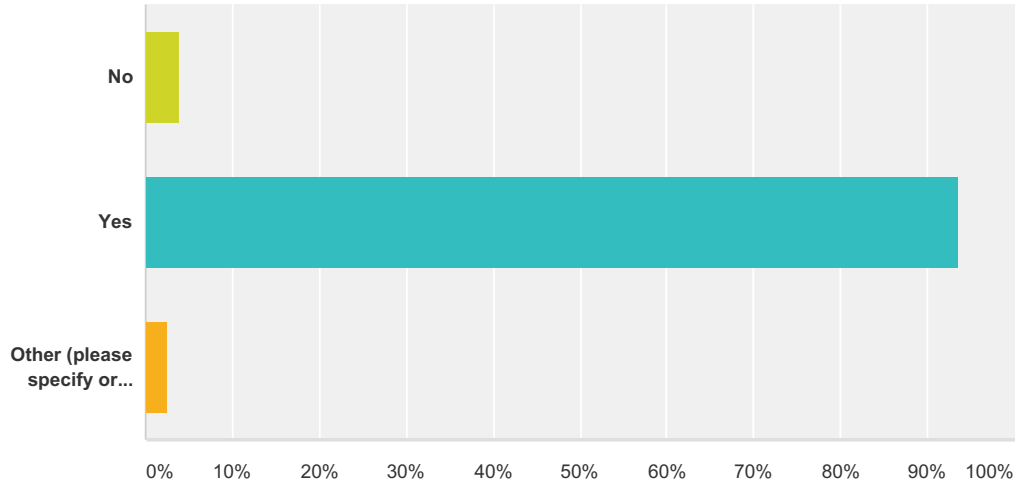


**Q1 Would you support OSPA and OSHP continuing to devote time and resources to create a proposed merger for membership review and vote within one year?**

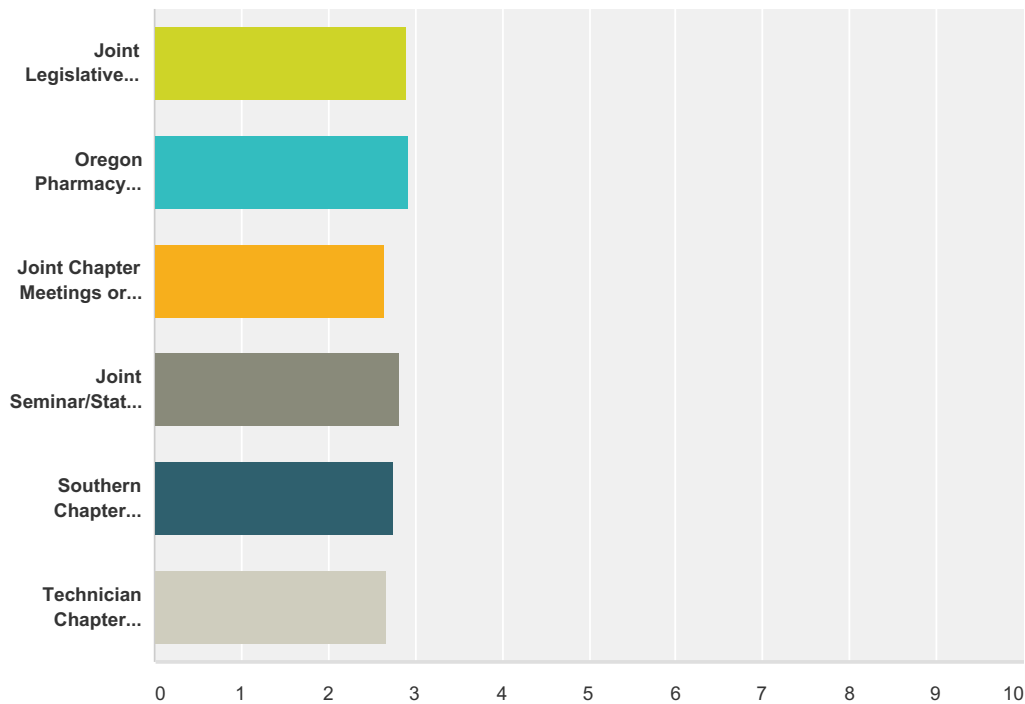

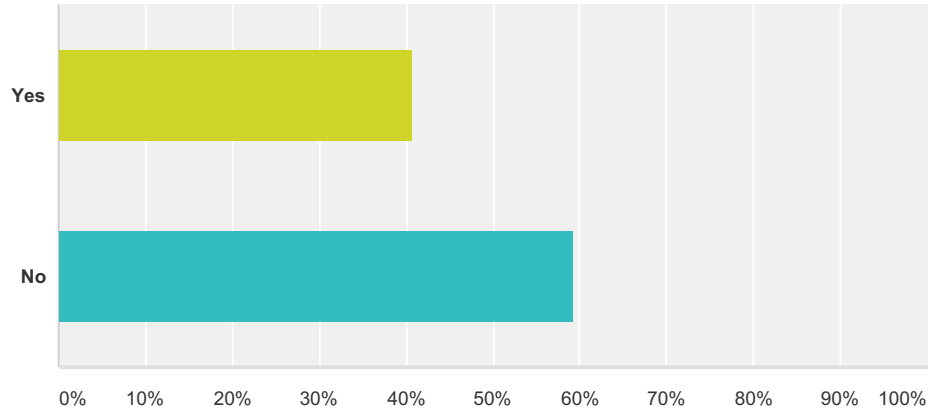
